NUCLEAR POWER PLANTS - THREE MILE ISLAND SPECIAL

INQUIRY GROUP

The Three Mile Island Special Inquiry Group is examining, in general, the health physics program of the various utilities operating nuclear power plants. They intend to use the results of this examination as a comparison to the TMI program. In pursuit of this inquiry they would like to discuss the radiation protection programs of nuclear power plant licensees with regional inspectors knowledgeable in this area and familiar with the utilities in their respective regions.
