Dear Ms. Grahamslaw;

I am writing in response to your letter to Commissioner Hendrie regarding Three Mile Island. I regret that this answer to your letter has been delayed. The accident and its consequences have created a substantial increase in the agency's workload, which has prevented me from responding to you as promptly as I would have liked to.

Metropolitan Edison (Met Ed) customers will not have to pay for any damages to, or for the restoration of, Three Mile Island Unit 2. The Pennsylvania Public Utility Commission, in a decision and order of June 15, 1979, ruled that customers of Met Ed and the Pennsylvania Electric Company would be free from accident expenses, except for those costs associated with purchasing power to replace power that would have been provided by the TMI facility.

The TMI accident and its effects have been investigated by the President's Commission and NRC. Please consult the Public Documents Room in the library in York College for information on reports prepared by the President's Commission and the NRC.
