During HFT and mini-HFT, instances of loss of feedwater to the main feedwater nozzles will occur. These instances are hard to classify into the existing categories of allowable operating transient cycles in the reactor coolant system functional specification.

The present categories are as follows. They are reserved for actual reactor trip or dry steam generator incidents, and are considered much more severe than the simple loss of feedwater situations being experienced during functional testing.

Initial Feedwater Temperature

Estimate of Time of Loss of Feedwater Flow Final Steam Pressure Final Feedwater Flowrate Final Feedwater Temperature
