Dear Governor Thornburgh:

Please accept my invitation to be our guest for the opening of the Nuclear Regulatory Commission's new office in Middletown, Pennsylvania, at 11:00 A.M. on January 30, 1980.

As you know, we have for some time wanted to provide a place where persons living in the vicinity of Three Mile Island could conveniently meet and talk with the senior NRC staff members who work on Three Mile Island in connection with the accident cleanup.

Both myself and Richard Volimer, Director of the NRC/TMI Technical Support Staff at Three Mile Island, and Deputy Director, John Collins, who is in charge there on a day-to-day basis and who now lives near the site, believe that the opening of the new office in Store No. 14, the downtown mall, 100 Brown Street, Middletown, Pennsylvania, will provide the public with more direct access and easier means of getting answers to the questions that people may have about what is going on at Three Mile Island.

In addition to Mr. Collins, the NRC Office of Public Affairs will be regularly represented in the new office and both Mr. Collins and Mr. Gary F. Sanborn, Field Public Affairs Officer, plan to be there until 8:00 P.M. each Wednesday to accommodate those who cannot visit them during normal daytime hours. The normal hours will be 11:00 A.M. to 3:00 P.M. Mondays, Tuesdays, Thursdays and Fridays, and 9:00 A.M. to noon on Saturdays.

We hope that you or your representative will be able to come and meet the NRC staff at the opening ceremonies, and I look forward to seeing you there.
