Subject: MAIN CONDENSER OFF GAS ACTIVITY

On December 16, 1979 the main condenser off gas radiation monitor (VAR 148/2) indicated an increase in gaseous activity from 4×10^{-7} uCi/cc to 2×10^{-4} uCi/cc. Local samples analyzed did not indicate activity above minimum detectable levels. Condenser off-gas samples taken on December 20, 1979 indicated 2×10^{-4} uCi/cc of Kr-85. Samples of the "A" OTSG indicate levels of Cs-137 and Cs-134 at a maximum concentration of 6×10^{-7} uCi/cc.

The gaseous release of about 1 uCi/sec to the environment due to this pathway is less than a thousandth of the Technical Specification limit upon such releases.

The licensee is monitoring the condenser off-gas and secondary water activities in an effort to determine the source of the increased activity.

This preliminary Notification is issued for information only.

The licensee does not plan a press release. NRC does not plan to issue a press release at this time.

The Commonwealth of Pennsylvania was notified by the licensee on December 20, 1979.
