Dear Mr. Hanna:

I am writing in response to your letter to the Commission requesting information about the accident at Three Mile Island. I regret that this answer to your letter has been delayed. The accident and its consequences have created a substantial increase in the agency's workload, which has prevented us from responding to you as promptly as we would have liked to. Should you still need material for your term paper, I would like to suggest the following NRC documents.

Several Nuclear Regulatory Commission reports are currently available that discuss the accident at Three Mile Island. The reports, their availability, and their costs are as follows:

"Population Dose and Health Impact of the Accident at the Three Mile Island Nuclear Station" (NUREG-0558), \$3.50;

"TMI-2 Lessons Learned Task Force Status Report and Short-Term Recommendations" (NUREG-0578), \$3.50;
