Dear Lt/Col. Garrett:

I am writing in response to your letter to Mr. Roger Boyd regarding your request for information about Three Mile Island. I regret that this answer to your letter has been delayed. The accident and its consequences have created a substantial increase in the agency's workload, which has prevented us from responding to you as promptly as we would have liked to.

In regard to your questions, the order for modification of the license for TMI-2 which appeared in the Federal Register 5 June 1978 was superseded by an order dated October 13. The order specified some additional provisions in the license. None of the problem areas addressed in the order played a role in either the accident or post accident events. There was no loss of offsite power and the emergency diesel generators were not the source of any problems.


