Northern California Power Agency and its members ("NCPA") hereby move for an extension of the date for one of NCPA's twelve members, the City of Santa Clara, California, to file its individual responses to "Pacific Gas and Electric Company's Fifth Set of Interrogatories to Northern California Power Agency and Department of Water Resources and Fourth Set of Interrogatories to the Cities of Anaheim and Riverside," dated July 19, 1979.

NCPA's interrogatory responses, including individual responses from each of its twelve members are presently due on March 3, 1980. 1/ NCPA is serving on March 3, 1980 complete responses from NCPA itself and from its members, the Cities of Alameda, Biggs, Gridley, Healdsburg, Lodi, Lompoc, Palo Alto, Redding, Roseville, Ukiah, California and the Plumas-Sierra Rural Electric Cooperative. The responses from Santa Clara are in the final stages of preparation, but due to
