Dear Mr. Shea:

This letter is in response to your letters dated March 20, 1978 and August 23, 1979, requesting Executive Branch views as to whether issuance of export licenses in accordance with the applications hereinafter described would be inimical to the common defense and security of the United States and whether the proposed exports meet the applicable criteria of the Atomic Energy Act of 1954, as amended by the Nuclear Non-Proliferation Act of 1978 (P.L. 95-242):

NRC Nos. XSNM01287 and XSNM01561 -- Applications by Westinghouse Electric Corporation for authorization to export to Yugoslavia 40 milligrams of U-235 in eight in-core neutron detectors and 16.4 milligrams of U-235 in four in-core detectors for use in the Krsko Nuclear Power Plant.

The proposed exports would take place pursuant to the Agreement for Cooperation Between the United States and the IAEA as well as the IAEA-Yugoslavia Supply Agreement of June 14, 1974, as amended, as confirmed in exchanges of notes between the U.S. Mission to the IAEA and the Agency and between the U.S. Embassy in Belgrade and the Yugoslav Foreign Ministry, copies of which are enclosed. The IAEA has adhered to the provisions of its Agreement for Cooperation with the United States.

The Executive Branch has reviewed the applications and concluded that the requirements of the Atomic Energy Act and P.L. 95-242 have been met and that the proposed

exports will not be inimical to the common defense and security of the United States. A detailed analysis is not believed necessary in view of the small quantity of material involved.

On the basis of the foregoing, the Executive Branch recommends that the licenses be issued.
