SUBJECT: AUXILIARY/CONTROL BUILDING MASONARY WALL TESTING RESULTS - ISSUANCE

OF IMMEDIATE ACTION LETTER

The NRR Project Manager informed Region V (San Francisco) of the results of recent testing of double-wythe masonary walls with mortared collar joints constructed of heavy weight blocks at the Trojan plant. These testing results were presented by the licensee at the ASLB Hearing currently in progress concerning the Control Building walls.

The results of the testing showed an average collar joint shear strength of 23 psi. A strength of 40 psi was relied upon by the NRR staff in its SER which provided the basis for the lifting of restrictions on the operation of the Trojan plant in December 1979.

The Trojan plant is currently shutdown for refueling.

An Immediate Action Letter (IAL) was sent to the licensee by Region V on April 17, 1980. The IAL confirmed an understanding between Region V and the licensee that prior to resuming reactor power operation this matter, including the completion of necessary modifications, will be resolved to the satisfaction of the NRC staff.
