- 2) copies of all documents or publications of the Nuclear Regulatory Commission, its staff, its advisory committees, or its contractors, which are distributed as a matter of course to one or more agencies in the Executive Branch of state government in Michigan, including, but not necessarily limited to, the Governor's office, the office of the Governor's Executive Assistant for Science and Technology (the Governor's Science Advisor), the Public Service Commission, the Radiological Health Division of the Department of Public Health, the Energy Administration, the Department of Natural Resources, and the Toxic Substances Control Commission.

I would also preatly appreciate it if you could arrange to have copies of the following documents sent to me:

- 1) communications between the Commission or its staff and American Electric Power Company (licensee of D. C. Cook units 1 and 2 near Bridgman, Michigan) or Consumers Power Company (licensee of Palisades unit 1 near South Haven, Michigan and Big Rock Point unit 1 near Charlevoix, Michigan) concerning changes in nuclear power plants required as a result of lessons learned from Three Mile Island incident (see NRC press release 80-1 of January 2, 1980),
- 2) communications between the Commission or its staff and Consumers Power Company (licensee of Palisades unit 1 near South Haven, Michigan) concerning the Company's alleged safety violations at the Palisades plant, for which NRC staff has recommended that a fine of \$450,000 be levied by the Commission (see NRC press release of November 9, 1979), and
- 3) communications between the Commission or its staff and Consumers Power Company (licensee to construct Midland units 1 and 2 near Midland, Michigan) concerning recent modifications in the construction permit for the Midland plant due to the licensee's failure to follow certain design and construction specifications in the permit, inclusion of incorrect information in its application for an operating license for the plant, and lack of supervision and control over certain construction activities (see NRC press release 79-215 of December 6, 1979), and
- 4) report NUREG-0610, which contains draft energency action level guidelines for radiological emergencies at nuclear power plants (see 44 Federal Register 55446 (September 26, 1979)).
