Subject: Interagency Agreement No. NRC-02-80-038 Entitled "Support of Continuing Activities of the U.S. National Committee for Rock Mechanics"

Dear Mr. Conneliy:

Pursuant to the Economy Act of 1932, the U.S. Nuclear Regulatory Commission (NRC) and the U.S. Bureau of Mines desire to enter into an agreement whereby the NRC will provide funds to support the Bureau of Mines' contract #J0199030 with the National Academy of Sciences. This contract is a cost-sharing effort, jointly funded by several Federal agencies.

## Article I - BACKGROUND/PURPOSE:

The NRC agrees to support the work of the U.S. National Committee for Rock Mechanics (of the National Academy of Sciences) by providing a portion of the administrative expenses of the Committee. NRC believes that the advancement of the science and engineering of rock mechanics will have a great influence on its ability to assess rock mechanics problems related to licensing and development of geologic repositories.

Article II - INTENT/SCOPE OF WORK:

It is the intent of the NRC staff to:

- Participate in meetings of the committee.
- 2. Serve on subcommittees and working groups, if requested.
- Provide input to research and program development needs and priorities, with emphasis on those related to licensing, design and construction of geologic repositories.
- Receive copies of guarterly and annual reports.
- Receive notices of special publications, meetings, workshops, etc.

## Article III - PERIOD GF AGREEMENT

The period of the agreement will be from date of execution by both parties through September 30, 1980.

## Article IV - REPORTS

The Bureau of Mines, through its contract with National Academy of Sciences, will provide the NRC copies of each Quarterly Activities Report and Annual Report covering the domestic and international activities/accomplishments of the U.S. National Committee For Rock Mechanics. The reports should be sent to the following address:

The U.S. Nuclear Regulatory Commission hereby obligates \$14,025.00 to support this cost-sharing effort. Bureau of Mines' voucher should be submitted in accordance with the attached billing instructions and should reference the following accounting data: B&R No. 50-19-03-01-0, FIN No. 932-0.
