

Dear Mr. Scarano:

By my letters dated September 28 and October 2, 1979, to Jack Martin, copies of the Edgemont Uranium Mill conceptual decommissioning plan and supporting environmental report (ER) were distributed to those listed in your September 21, 1979, letter to J.
