As counsel for Velsicol Chemical Corporation and pursuant to the provisions of the Freedom of Information Act, 5 USC 552, we request that you provide us with the following public records relating to the inspection conducted by your agency and other federal and State of Michigan agencies, with the consent of Velsicol, on or about January 24, 1980. The inspection involved the premises and/or sites located at (1) Velsicol Chemical Corporation, 500 Bankson Street, St. Louis, Michigan; and (2) Velsicol Chemical Corporation Rare Earth Burial Site in T12N, R2W, Section 23, Gratiot County, Michigan, and included the taking of soil, sediment and water samples, and radiation readings at said sites. The information requested includes but is not limited to:

1. All field notes;
2. All gross measurements of radiation intensity or dose rate at and/or about the sites;
3. All measurements of radioactive concentrations found in soil, water or other samples taken at the sites;

4. Any data compilation showing measured radiation values;

5. Any grid or contour map showing points and/or contour lines of:


(a) measured radiation values, or

(b) location of water or soil samples and measured level of radioactivity; and

6. Any evaluative and/or summarizing memoranda, studies or reports relating to the search.
