- Accordingly, the license is amended by a change to the Technical Specifications as indicated in the attachment to this license amendment and all paragraphs under 3.B of Facility License No. DPR-6 are hereby amended and replaced with the following:

# CHANGE NO. 43 TO TECHNICAL SPECIFICATIONS (APPENDIX A)

## FACILITY OPERATING LICENSE NO. DPR-6

The Technical Specifications contained in Appendix A attached to the Facility Operating License No. DPR-6 are revised as follows:

Replace paragraph 4.1.1.(g) with the following:

(g) Control Rod Guidance

2 ml

The 32 cruciform-shaped control rods shall be guided and supported by the "fuel channel and support tube" assemblies. Each control rod shall contain a maximum of eight (8) rollers to a minimum of four (4) rollers of either a nominal 0.485-inch or 0.567-inch diameter. The bottom four (4) rollers, which can be eliminated, shall move in a minimum interfuel channel space of 0.628 inch.
