Subject CONTRACT GUARD EMPLOYEE INJURED ON FIRING RANGE

A contract guard service employee was shot in the foot when her .22 caliber revolver accidentally discharged during supervised range practice at the Wiscasset Rod and Gun Club on April 17, 1980. The guard trainee was admitted for treatment to Bath Memorial Hospital. The trainee has since been released from the hospital and will be off duty for 6-8 weeks.

The news media has contacted the licensee to confirm the facts of the event. A press release is not planned by the licensee or the NRC.

The State of Maine has been informed. NRC, Region I received notification of this occurrence from Region I inspectors on site at 3:30 p.m. on April 22, 1980.
