Dear Mr. Tappan:

This is in reply to your letter dated May 8, 1980, in which you requested, pursuant to the Freedom of Information Act, copies of two reports you identified as well as a copy of the NRC's Gray Book dated January, 1980.

In response to your request, we have identified the documents listed in Appendix A as being subject to your request. A copy of each document is enclosed.

As explained by Mr. Frank W. Karas of this office in a telephone conversation with you on May 15, 1980, the charge for reproducing records not located in the NRC Public Document Room is ten cents (\$0.10) per pace, as specified in 10 CFR 9.14(b), a copy of which is enclosed. Accordingly, the cost of reproducing the enclosed 458 pages of Appendix A documents 1, 2, and 3 is \$45.80.

Please send a check in the amount of \$45.80 along with a copy of this letter to the Director, Division of Rules and Records, Room MNBB-4210, U.S. Nuclear Regulatory Commission, Washington, DC 20555.

In response to your question on a waiver or reduction of fees, please note that normally a request for fee waiver is to be made at the time the initial request for records is made (\$9.14(b)(5)), and that the NRC's regulations provide that in making a request for waiver or reduction of fees, the requester shall provide a statement setting forth the information required in \$9.14a(c).

Finally, as Mr. Karas explained, we have no record of having received your previous request.
