I. Facility Contacts (telephone)

A telephone survey was conducted in the Ft. Lauderdale area as a trial method for determining frequent hindlers of radioactive material shipments. Most of the following listed facilities affirmed that they do handle some radioactive material shipments, but on an infrequent basis. II. Facilities Visited

III. Facility and/or Package Inspections

Of the additional terminals contacted during this quarter, none appeared to be handling the volume of radioactive material packages as that of the Purolator - Orlando facility.

During our initial visit to the Tampa and Ft. Lauderdale terminals previously listed, no radioactive material packages were present at that particular time.

During a later visit on a Sunday night to the Purolator-Tampa terminal, only three radioactive material packages were present. A truck was due later that night from the Purolator - Orlando terminal with a large shipment of radioactive material packages. Likewise, during our visit to the Purolator - Ft. Lauderdale terminal, it was reaffirmed that most of their radioactive material packages are received from their Orlando terminal. Again, the majority of Purolator's radioactive material packages can be inspected early on Sunday evenings in Orlando.

VI. Transportation Reviews Conducted During Routine Radioactive Materials License Inspections

- A. During many of the routine inspections of Florida Radioactive Materials Licensees, their transportation aspects are being reviewed by the inspector. Those additional facilities that are licensed to use radioactive materials for which reports concerning their transportation of radioactive materials were submitted this quarter are as follows:

B. During the 2/14/80 inspection of Titanium Enterprises, their transportation procedures were reviewed. TE no longer ships "LSA-Radioactive" material by rail to Tennessee. Instead, they ship to the Port at Jacksonville via truck (Crown Motor Lines). It is TE's responsibility to provide proper placards. The representative of TE being interviewed stated that the trucking company had said they would refuse to ship for them if placards were placed on their trucks. When the TE representative was advised that such placards were necessary, he obtained one from a nearby cabinet. When he was told that one on each of the four sides of the vehicle was required, he said that he was not aware of that requirement because he had been told otherwise.

VII. Transportation Incidents

One transportation incident was reported during this second quarter of the contract.

Word was received by our Miami office from the Texas Radiation Control Program that a shipment containing $^{241}\mathrm{Am}$ -Be and $^{137}\mathrm{Cs}$ was missing that had been shipped from Texas to Peru through the Miami Airport. A search and survey of the Miami Airport freight handling facilities revealed nothing. Paper work reviewed indicated that the shipment had left Miami via Airlift International, but was not accounted for upon arrival of the flight in Peru.

VIII. Planned Activities

The third quarter activities planned under this contract are as follows:

- a. Inspect terminal facilities in the Miami area.
- b. Inspect the vehicles delivering from out-of-state to the Purolator-Orlando terminal on weekends.
- c. Inspect the packages and handling of same at the Purolator-Orlando terminal on Sunday nights.
- d. Inspect reactor low level waste shipments. (None of these were reported inspected during the second quarter.)
- e. Continue to monitor the facilities that demonstrate relatively high readings on their area TLD devices.
