I Gary Hutzel of legal age and
being duly sworn, state

1. That I live in Soluda Township
in Jefferson County, Missouri and that I
was employed by Newberg Construction Company
at Marble Hill through Carpenters Union
no. 3210 from March/1979 to May/1979

2. That my particular job at Marble
Hill as a full carpenter: building cement forms.
In this capacity, I only saw cement pouring
at a distance.

3. That I have observed cement pouring
in bad rain conditions in various structures
on site.

4. That I knew, at one point that, cement
pouring was stopped because it was raining
too hard to continue.

5. That I have personally seen pours
of more than 10 feet up to at least 16 foot high.

6. That I have personally seen honeycomb
areas in reactor no. 1 at least 1 yard wide
when we removed forms and cement appeared
weak at these honeycombs.

7. That I have personally seen repaired
cement in process being pumped out after jack
hammering with water & probably, open water,
standing in the hole - often a yard or more across
and 2 or 3 feet deep.

8. That I personally observed a form that was installed — was poured full of cement and I went back and saw a guide line on a the form indicating bulged pour up to 1 inch the wall about 5 feet high and 40 feet long. This was because there was nothing to brace forming to.

9. That I considered this job very unsafe some was dropping heavy objects often & welds and other heavy objects. I have told my steward we needed nets for safety.

10. That I have never knowingly seen an osha man inspect the job for worker safety.

11. That I have personally seen much construction junk where I was setting forms at the reactor building. I never knew if it was cleaned before the pour.

12. That I worked 7d shift as a carpenter with about 50 other carpenters. One of the 50 men was black.

13. There were about 20 carpenter helpers on my shift including 4 or 5 blacks and 2 or 3 women. These helpers were to help carpenters but were in the laborers union. These came and went pretty fast.

I have read the foregoing of 2 pages and 13 sub paragraphs of the affidavit and believe every statement therein to be true to my best knowledge.
