Dear Mr. Shea:

I refer to the letter from your office dated April 18, 1980, requesting Executive Branch views as to whether issuance of an export license in accordance with the application hereinafter described would be inimical to the common defense and security of the United States, and whether the proposed export meets the applicable criteria in the Atomic Energy Act of 1954, as amended by the Nuclear Non-Proliferation Act of 1978:

NRC No. XCOM0393 -- Application by Westinghouse Electric Corporation for authorization to export to Australia one incore fission chamber of a total value of \$2,415.00 for use in the Australian Atomic Energy Commission's research reactor HIFAR at Lucas Heights.

It is the judgment of the Executive Branch that the export contemplated will not be inimical to the common defense and security of the United States, and that this export is consistent with the provisions of the Atomic Energy Act of 1954, as amended by the Nuclear Non-Proliferation Act of 1978.

As an NPT party, Australia has committed itself to maintaining IAEA safeguards on all of its peaceful nuclear activities and has pledged not to produce or otherwise acquire any nuclear explosive device. It is therefore the judgment of the Executive Branch that criteria (1) and (2) for exports of reactor components under Section 109 b of the Atomic Energy Act, as amended, are met. The remaining criterion, agreement not to retransfer any U.S.-supplied

On the basis of the foregoing, the Executive Branch recommends that the license be issued.

Dear Mr. Nosenzo,

In response to your letter of April 28, 1980, regarding NRC Application No.XCOM 0393 (Reference NRC No.XSNM 01651) and the criteria that must be met as a condition of issuance of NRC export licenses, I have received the following information by cable from the Australian authorities:

"We confirm that the incore fission chamber ordered by the University of NSW will not be retransferred without the prior approval of the United States, in accordance with Article 11(B) of the 1957 Agreement between Australia and the USA for co-operation concerning the civil uses of atomic energy."

I have also been advised that the Australian authorities soon will provide a reply to your letter of December 18, 1978, regarding a generic assurance concerning retransfers.

With reference to para 1 of your April 28 letter, I wish to clarify the information presented in the NRC export license application, namely, that the University of New South Wales School of Nuclear Engineering intends to use the incore fission chamber in the tralian Atomic Energy Commission's research reactor HIFAR which is located at the AAEC Research Establishment at Lucas Heights (near Sydney).
