Dear Mr. Schefrin:

This is in response to your letter of April 21, 1980, in which you requested, pursuant to the Freedom of Information Act, names and addresses of personnel who were involved with the use of by-product radioactive materials at the Rhode Island Hospital.

Please find enclosed, as listed on Appendix A, the names and current positions of NRC personnel who were responsible for the use of those materials at the Rhode Island Hospital between 1958 and 1972.

The names of persons who were responsible for that function on behalf of the hospital are enclosed as Appendix B.

The Code of Federal Regulations (10 CFR - Energy) manual chapters which would be applicable to your request are Part 19, "Notices, Instructions and Reports to Workers; Inspections;" Part 20, "Standards for Protection Against Radiation;" and Part 30, "Rules of General Applicability to Domestic Licensing of Byproduct Material." Copies of the Code of Federal Regulations can be found at the U.S. Depository Libraries located in Providence, as enumerated on Appendix C. In addition, should you desire a complete set on microfiche, it can be ordered through the Information Handling Service, 15 Inverness Way, E., Englewood, Colorado 80150. In order to obtain all the years covered by your request, you would need to order set AE 1948-73 plus title 11 AE 1947. The cost for the set would be \$110.
