Dear Mr. Blossfeld:

Enclosed is Amendment No. 52 to your NRC Materials License No. 21-00016-04 in accordance with your request. Please note that your license format has been changed based on our new Web-based Licensing system.

In addition, the following License Conditions have been updated to the current standard license conditions in accordance with the licensing policy: Condition No. 18 regarding the sealed source leak test requirements, Condition No. 19 regarding the licensed material inventory requirement, Condition No. 20 prohibiting the removal of radioactive material from their capsules or devices, as applicable, and Condition No. 22 regarding the decay-in-storage requirements. We also deleted Condition No. 23 regarding the transportation requirement in your previous amendment (Amendment No. 51) because this requirement is already in the regulations (10 CFR part 71).

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
