Dear Mr. Givel:

This is in partial response to your undated letter received by our office on May 15, 1980, in which you requested, pursuant to the Freedom of Information Act, 22 categories of documents regarding the Crystal River 3 Nuclear Power Plant.

The following responses are subject to your request under the specific items as enumerated in your letter:

ITEM 1: No records exist, as the Barnwell, South Carolina, reprocessing plant has never been in operation.

ITEM 2: Names of individuals exposed to radiation are withheld from public disclosure pursuant to Exemption (6) of the Freedom of Information Act (5 U.S.C. 552(b)(6)) and 10 CFR 9.5(a)(6) of the Commission's regulations, because disclosure of this information would constitute a clearly unwarranted invasion of personal privacy.

ITEM 3: With respect to security incidents and threats, the following is the list of all such events since issuance of the operating license:

3/17/79	Bomb Threat
3/21/79	Bomb Threat

With respect to items of noncompliance related to physical security, please find enclosed cover sheets for inspection reports as listed on Appendix A. In addition, an inspection conducted on January 6-7, 1977, (Inspection Report No. 50-302/77-01) disclosed items of noncompliance in the following areas: Access controls, Records of physical examinations of guards, and Guard training records. The remaining portion of the documents listed in Appendix A contain information which identifies procedures for safeguarding licensed special nuclear material or detailed security measures for the physical protection of a licensed facility or plant. This information is considered commercial or financial (proprietary) information pursuant to 10 CFR 2.790(d) and is being withheld from public disclosure pursuant to Exemption (4) of the Freedom of Information Act (5 U.S.C. 552(b)(4)) and 10 CFR 9.5(a)(4) of the Commission's regulations.

Pursuant to 10 CFR 9.9 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The person responsible for this denial is the undersigned and Victor Stello, Director, Office of Inspection and Enforcement.

This denial may be appealed to the Commission's Executive Director for Operations within 30 days from the receipt of this letter. As provided in 10 CFR 9.11, any such appeal must be in writing, addressed to the Executive Director for Operations, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision."

ITEMS 4, 6, 8, 9, and 10: Documents, as listed on Appendix B, respond to these categories.

ITEM 5: Our initial search indicates that it will take approximately 8 hours of professional search time (@ \$12.00 per hour) and an additional 8 hours in order to reproduce documents.

ITEM 7: Please find enclosed NUREG-0002.


ITEMS 11 and 12: The Freedom of Information Act (5 U.S.C. 552) applies only to requests for, or access to, records. Since your request under these two categories is for information rather than access to records, it is not a proper request made pursuant to the Freedom of Information Act.

ITEMS 13 through 22: Documentation is in the form of Licensee Event Reports (LERs) submitted by the Florida Power Corporation. These documents are available for public inspection and copying at the following address: Crystal River Public Library, 668 N.W. 1st Avenue, Crystal River, Florida 32639 (904-795-3716).

The charges for searching for and reproducing records are specified in 10 CFR 9.14, a copy of which is enclosed.

We were unable to reach you by telephone, as your number was reported disconnected, to relay the above information to you.
