In your memorandum, you noted that the Committee to Review Generic Requirements has approved the Generic Letter in its current form. Furthermore, you stated that the Advisory Committee on Reactor Safeguards (ACRS) had been briefed on the subject Generic Letter and although they did not offer any written comments or endorsements, they did raise two particular concerns regarding scope of the Generic Letter and the difference between NRC and industry cost estimates. Since the date of your memorandum, your staff has responded to these ACRS concerns and provided dditional information at ACRS meetings held during the first week of May.
