THIS REQUEST INCLUDES ALL AGENCY RECORDS AS DEFINED IN 10 CFR 9.30 (b) AND THE NRC MANUAL, WHETHER THEY CURRENTLY EXIST IN OFFICIAL "WORKING" INVESTIGATIVE OR OTHER FILES OR AT ANY OTHER LOCATION INCLUDING PRIVATE RESIDENCE OR STORAGE FACILITIES AND SO ON.

FOR ANY NRC RECORDS OR PORTIONS OF SUCH RECORDS THAT ARE DENIED BY AN NRC OFFICIAL

PLEASE PROVIDE AN INDEX (ITEMIZING) AND SPECIFICALLY (WITH PARTICULARITY) DESCRIBING THE DOCUMENTS

OR PORTIONS OF DOCUMENTS WITHHELD. THE INDEX SHOULD PROVIDE A DETAILED BRIEF IN FACT AND LAW FOR CLAIMING EACH EXEMPTION, EXPLAINING WHY EACH EXEMPTION IS JUSTIFIED AND RELEVANT

TO THE RECORD OR PORTION OF THE RECORD WITHHELD
