TMI-2 Organization Plan - Revision 21

Dear Sirs:

Attached for NRC review and approval is Revision 21 to the TMI-2 Organization Plan. The GPU Nuclear Corporate re-organization is proposed for implementation during November 1989 and to be fully effective December 1, 1989. This corporate re-organization has no direct impact on the clean-up operations at TMI-2. The TMI-2 organization remains a separate division within GPU Nuclear Corporation with its own engineering and technical support functions. However, the change does affect GPU Nuclear Divisions which provide support to the TMI-2 organization.

The following is a description of the revised responsibilities of the GPU Nuclear organization.

- o The Administration and Finance Division will provide support in the areas of materials management, operations analysis, accounting, budget, and rate case support. The security function will be transferred to the newly-created Site Services Division. This change is administrative in nature and does not affect the safety function of the organization.
- o The Nuclear Assurance Division will combine the functions of the previous Quality Assurance and Training Division and the previous Radiological and Environmental Controls Division. Therefore, the Nuclear Assurance Division will provide support in the areas of environmental monitoring and controls, TMI-2 radiological controls, emergency preparedness,


quality assurance, and training and education. This change is administrative in nature and does not affect the safety function of the organization.

- o The Site Services Division will provide support in the areas of construction, facilities, security, and transportation. Except for security, which was assumed from the previous Administration Division, these functions were assumed from the previous Maintenance, Construction, and Facilities Division. This change is administrative in nature and does not affect the safety function of the organization.
- o The Corporate Services Division will provide support in the areas of licensing, planning, and human resources. The latter function was assumed from the Administrative Division. The other functions were assumed from the previous Planning and Nuclear Safety Division. This change is administrative in nature and does not affect the safety function of the organization.
- o The Technical Functions Division will remain as currently constituted.
- o In addition, five smaller, independent functions will report to the Office of the President:
 - Independent Safety Review to include General Office Review Board (GORB), Nuclear Safety Analysis Department (NSAD), Ombudsman, and Risk Management;
 - Communications;
 - Corporate Secretary;
 - Legal Services; and
 - Outage Management.

The proposed re-organization is administrative and, as such, does not involve a change to the TMI-2 Recovery Technical Specifications nor result in an unreviewed safety question. The re-alignment of functional responsibilities is intended to enhance the organizational capability to provide appropriate technical resources to ensure that the nuclear facilities shall be operated and maintained in a safe, effective, and efficient manner.

The position of Executive Vice President will be eliminated in June 1990 upon the planned retirement of the incumbent.
