Enclosed please find three changes to our Topical Report (QA Program) that we are submitting for your information, in accordance with 10CFR50.55(f)(3), as directed by a letter from Mr. S. H. Weiss of the NRC. The letter is included in a copy of the current accepted revision of the Topical Report also enclosed.

The changes are presented as Notifications of Revision (NORs) 098, 102, and 100 to the Topical Report.
