This letter refers to the routine safety inspection of activities authorized by NRC License Nos. DPR-61, 65 and NFP-49 conducted by Mr. C. Amato of this office on September 11 to 15 and October 2 and 5, 1989, at your Millstone Nuclear Power Station, Waterford, Connecticut. Discussions of our findings were held by Mr. Amato with your staff at the conclusion of the inspection.
