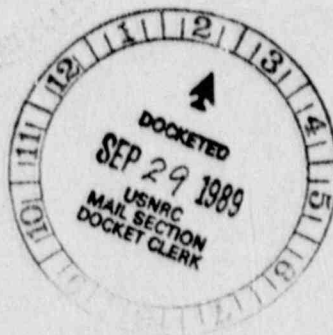

Dear Mr. Hall:

As you may know, BP America, Inc. (BPA) recently concluded a transaction whereby the majority of our minerals business was sold to RTZ. As part of this transaction, both Sohio Western Mining Co. and Kennecott Corporation became part of RTZ. Sohio Western Mining Co. owns the L-Bar Uranium Mine Property.

In light of these recent events, EPA is requesting an amendment to existing license SUA-1472. We request that License Condition No. 1 (i.e. "Licensee") be changed from BPA to Sohio Western Mining Co., a wholly-owned subsidiary of Kennecott Corporation. Likewise, we request that License Condition No. 2 be changed to reflect Kennecott's current address as 10 East South Temple, P.O. Box 11248, Salt Lake City, Utah 84147.

I should also mention that the revised reclamation bond with NRC, as discussed in your August 25, 1989 letter, will be issued in Kennecott's name rather than BPA's name. Consequently, we request that License Condition No. 25 be changed to reflect this fact. You should be receiving a new surety bond from Kennecott in the near future.

Intera Technologies, Inc. will continue as the Site Contractor until further notice. BPA will continue to serve as the L-Bar Project Manager until sometime around the end of this year in order to ensure a smooth transition period. Therefore, we request that License Condition No. 27 remain unchanged for now. As such, I will continue to serve as the NRC contact for this project. 
