1.0 INTRODUCTION

By letter dated June 30, 1989, Portland General Electric Company (PGE, the licensee) requested changes to the Trojan Technical Specifications (TTS). This License Change Application (LCA) 182 would revise Section 6.0 of the TTS to reflect a reorganization at the PGE Nuclear Division.

Specifically, the following changes are proposed.

- Organizational title in Sections 6.1.1, 6.5.1.1, 6.5.1.7.a, 6.5.1.7.c, and 6.14.2.b changed from "General Manager" to "Plant General Manager".
- Responsibility for the direction of the Training Department in Sections 6.4.1 and 6.4.2 changed from "the General Manager" to "a General Manager".

2.0 EVALUATION

A reorganization of Portland General Electric Company's (PGE's) Nuclear Division included transfer of the Training Department from the Nuclear Plant Group to a newly created Plant Support Group. Applicable TTS sections are revised prior to implementation of this change.

TTS sections 6.4.1 and 6.4.2 are revised to reflect the general level to which the Training Department will report, (i.e., "a General Manager") rather than specific group title. This will avoid having to introduce a new title (i.e., "General Manager, Plant Support Group") without the benefit of an organization chart in the TTS, while still showing that the Training Department will continue to report to a high level of management, even a higher level (General Manager) after the reorganization, than previously. In addition, the absence of a specific group title will allow flexibility for future reorganizations involving the Training Department without having to necessarily revise the TTS.

8911170226 891106 PDR ADOCK 05000344 P PDC Other changes to Section 6.0 of the TTS are the result of a general review of this section for the impact of the reorganization. Changing references from "General Manager" to "Plant General Manager", where appropriate, will result in a more consistent and specific definition of the responsibilities of the Plant General Manager within Section 6.0.

The staff has reviewed the proposed changes to Section 6.0 of the TTS, and finds them to be administrative in nature, and finds that there is no change to the functional responsibilities of maintaining adequate operational safety. Therefore, the proposed changes are appropriate and acceptable.

3.0 CONTACT WITH STATE OFFICIAL

The NRC staff has notified the Oregon Department of Energy of the proposed issuance of this amendment along with the proposed determination of no significant hazards consideration. No comments were received.

4.0 ENVIRONMENTAL CONSIDERATION

This amendment relates to changes in recordkeeping or administrative procedures or requirements. Accordingly, the amendment meets the eligibility criteria for categorical exclusion set forth in 10 CFR 51.22(c)(10). Pursuant to 10 CFR 51.22(b), no environmental impact statement or environmental assessment need be prepared in connection with the issuance of the amendment.

5.0 CONCLUSION

We have concluded, based on the considerations discussed above, that (1) there is reasonable assurance that the health and safety of the public will not be endangered by operation in the proposed manner, (2) such activities will be conducted in compliance with the Commission's regulations, and (3) the issuance of the amendment will not be inimical to the common defense and security or to the health and safety of the public.
