Dear Mr. Kasun:

This is in response to your letter of August 12, 1989, in which you requested three items of information. The items requested are being provided as follows:

 <u>Contract between Public Service Company of Colorado</u> (PSC) and Nuclear Fuel Services (NFS) (referred to in item 3 of GA's letter dated July 25, 1989)

Since this is a contract between PSC and NFS, we have asked PSC to provide you that information directly. A copy of a letter to PSC dated August 23, 1989, making the request is enclosed.

2) <u>General Atomics' (GA) agreement with PSC on this</u> matter

There are no agreements on this arrangement with PSC. Through conversations with PSC's staff, GA was aware that there was an effort with NFS and the NRC for special arrangements concerning measurement of this material. GA's opinions were not solicited. It was only after the exemption was granted by the NRC and the shipments made to NFS that we learned that PSC intended to hold GA responsible for measurement differences which would be identified several years into the future. Had GA known PSC's position prior to shipment, GA would have raised its concerns with PSC and the NRC and required a resolution before making any shipments to NFS.
