Gentlemen:

This refers to the telephone conversation between you and other members of your staff and Dr. Bruce Mallett of my staff and me on October 4, 1989 regarding arrangements for a meeting between members of our organizations. This meeting is scheduled for 10:00 a.m. (CDT), November 7, 1989 in the Region III office. It is our understanding that University attendees will include you, Drs. H. Elson and J. Wiot and Messrs. C. Kupferberg and F. Trejo. NRC attendees will include Mr. A. Bert Davis, Regional Administrator, Dr. Carl Paperiello, Deputy Regional Administrator, Mr. John Grobe, Director, Region III Enforcement and Inspection Coordination Staff, Dr. Bruce Mallett, Wayne Slawinski and myself.

As discussed in the telephone conversation, the purpose of the meeting is to discuss your progress in identifying and correcting problems in your radiation safety program. We ask that you be prepared to discuss the following four issues:

1. The extent to which University officials notified NRC of the University's finding that the Radiation Safety Officer may have removed records to prevent them from being reviewed by an NRC inspector.
2. The extent of the Radiation Safety Committee's oversight and audit of the radiation safety program in the past and present.
3. The effectiveness of the Radiation Safety Committee in performing its normal function in the past and present, including whether membership, fragmentation and/or availability of members have had any affect on this function.
4. The findings and status of corrective actions implemented as a result of your ongoing review of the radiation safety program at the University, including the items specified in our August 30, 1989 Confirmatory Action Letter.
