This letter refers to the enforcement conference held between Clarence Silvia, Alan Melton M.D., and Michele Rispoli of your staff and Malcolm R. Knapp and other members of the NRC Region I staff on August 1, 1989, relating to activities authorized by the NRC license issued to Bradley Memorial Hospital and Health Center. It is our view that this conference was beneficial in that it allowed us to express our concerns regarding the apparent violations identified during the inspection conducted on March 30, 1989, and allowed us to better understand your actions to correct the violations. 
Enforcement action resulting from this inspection has been provided to you under separate cover.
