This modification is issued to provide incremental funding in the amount of \$99,525.00 under the subject contract. Accordingly, the following change is hereby made:

Under subsection B.1 Consideration and Obligation, the first sentence of paragraph b. is revised to read as follows:

"The amount presently obligated with respect to this contract is increased by \$99,525.00 from \$251,000.00 to \$350,525.00."

All other terms and conditions, including the contract ceiling amount of \$700,000.00, remain the same.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
