Koshy of this office on August 28 to September 1, 1989 at Bolton, Massachusetts of activities authorized by NRC License No. DPR-36 and to the discussions of our findings held by Mr. T. Koshy with Mr. P. Anderson of your staff at the conclusion of the inspection.
