14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

This modifications is issued to extend the period of performance end date through November 27, 1989 at the same hourly rates/unit prices as currently reflected under this contract. As a result of this action funding is provided for this extension period in the amount of \$5,985.00 which increases the obligated and ceiling amounts from \$102,550.00 to \$108,535.00. Also, under subsection B.1 - Brief Description of Work, the estimated number of hours and the total estimated amount for line item number one, On-Call Maintenance Charges, as well as the total estimated amount for all services under this contract, is revised to reflect the amount currently obligated under this contract. Accordingly, the following changes are hereby made:

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

1. Under Subsection B.1 - Brief Description of Work, the first line item is revised to reflect the current estimated number of hours and total amount as well as the total estimated amount for all services as follows:

2. The total estimated amount of this contract as well as the obligated amount is hereby increased by \$5,985.00 from \$102,550.00 to \$108,535.00. As a result of this action, the contract is fully funded at \$108,535.00.

Therefore, the first sentence in paragraphs a. and b. of subsection B.2 - Consideration and Obligation-Delivery Orders (MAR 1989) are revised to read as follows:

- "a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$108,535.00.
- b. The amount presently obligated with respect to this contract is \$108,535.00."
3. Subsection F.2 - Duration of Contract Period (MAR 1989) is revised to read as follows:

"The contract shall commence on 11/1/87 and will expire on 11/27/89."

Note: The amount obligated by this modification of \$5,985.00 includes the temporary ceiling of \$5,000.00 verbally authorized on 10/26/89.

All other terms and conditions under this contract remain the same.
