SUBJECT: DATE OF DECOMMISSIONING TRUST AGREEMENT

Dear Ms. Amstutz and Mr. Compernolle:

This letter clarifies any potential confusion regarding references to the original Decommissioning Trust Agreement. The copy of Decommissioning Trust Agreement on file with the U.S. Nuclear Regulatory Commission (NRC) and the copy on file with TNB Financial Services, Inc. (TNB Financial) have identical terms, but there are different dates at the top of the documents. The NRC's copy does not have an exact date, instead listing only "November ___, 2003,"¹ and TNB Financial's copy has "November 18, 2003" listed as the date, with the "18" being handwritten. Adding to the confusion, Amendment No. 1 dated April 13, 2005, and Amendment No. 2 dated October 30, 2019 both refer to "The Decommissioning Trust Agreement, dated as of December 23, 2003."²

The variation in dates used to reference the original Decommissioning Trust Agreement are likely due to the pendency of Fansteel's reorganization plan before the U.S. Bankruptcy Court for the District of Delaware (the Bankruptcy Court) in November and December 2003. As part of its reorganization plan, Fansteel proposed to create FMRI to assume the NRC license and complete decommissioning.

The Bankruptcy Court had confirmed a reorganization plan on November 17, 2003—likely explaining why TNB Financial's copy of the Decommissioning Trust Agreement is dated the day

after, November 18, 2003.³ After this reorganization plan was confirmed, however, Fansteel subsequently entered into a settlement agreement with the State of Oklahoma regarding the transfer from Fansteel to FMRI of Fansteel's Oklahoma Pollutant Discharge Elimination System Permit for the Muskogee site. Accordingly, Fansteel modified the reorganization plan to reflect this settlement agreement.⁴ Ultimately, the Bankruptcy Court confirmed this second reorganization plan on December 23, 2003.⁵ Therefore, both Amendment No. 1 and Amendment No. 2 refer to "The Decommissioning Trust Agreement, dated as of December 23, 2003."

The date discrepancy is the sole difference between the NRC's and TNB Financial's executed copies of the Decommissioning Trust Agreement—both documents are otherwise identical. As such, all parties agree that the date discrepancy has no effect on the effectiveness of the Decommissioning Trust Agreement, Amendment No. 1, and Amendment No. 2.
