
On page 3 of its Memorandum and Order of July 20, 1976,

In this case, the record is sparse on such questions as what work SS&D did for the city as bond counsel in 1968, 1972 and 1973; how this work is related to the present antitrust proceeding; and what work Mr. O'Loughlin or his subordinates did for the City; the extent to which Mr. O'Loughlin was responsible for his subordinates' work and whether his or their work was substantially related to the present antitrust proceeding; what explanations of existing or potential conflicts of interest were made by SS&D to the City in either 1968 or 1972; what the City's state of knowledge with respect to such conflicts was when it retained SS&D as bond counsel in 1968 and 1972; and what was the scope, nature and extent of the consent (if any) given by the City in each of those years to SS&D's then-existing and potential future conflicting representation of CEI. We expect that, on the remand to the Special Board which we are now directing, the parties will offer evidence and the Board will make findings with respect to these issues.
