AMENDMENT TO PROVISIONAL CONSTRUCTION PERMIT

Amendment No. 1 Construction Permit No. CPPR-51

- 1. The Nuclear Regulatory Commission (the Commission) having found that:
 - A. The application for amendment filed as Amendment No. 46 to the application for License, dated August 13, 1975, complies with the standards and requirements of the Atomic Energy Act of 1954, as amended, and the Commission's rules and regulations set forth in 10 CFR Chapter I;
 - B. The City of Alachua, City of Bushnell, City of Gainesville, City of Kissimmee, City of Leesburg, City of New Smyrna Beach and Utilities Commission, City of New Smyrna Beach, City of Ocala, Orlando Utilities Commission and City of Orlando, Sebring Utilities Commission, Seminole Electric Cooperative, Inc., and the City of Tallahassee are financially qualified for joint participation in the ownership of the proposed facility; and
 - C. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public.

- Accordingly, Provisional Construction Permit No. CPPR-51 is amended to reflect changes in the ownership of the facility as follows
 - A. Paragraph 1. is deleted and the following paragraph is substituted:
 - Pursuant to Section 104 b. of the Atomic Energy Act of 1954, as amended, (the Act), and Title 10, Chapter I, Code of Federal Regulations, Part 50, "Licensing of Production and Utilization Facilities," the Nuclear Regulatory Commission (the Commission) hereby issues an amended construction permit to Florida Power Corporation, City of Alachua, City of Bushnell, City of Gainesville, City of Kissimmee, City of Leesburg, City of New Smyrna Beach and Utilities Commission, City of New Smyrna Beach, City of Ocala, Orlando Utilities Commission and City of Orlando, Sebring Utilities Commission, Seminole Electric Cooperative, Inc., and City of Tallahassee, (the applicants), as their interests appear in the application, as amended, for a utilization facility (the facility), designed to operate at 2452 megawatts (thermal), described in the application and amendments thereto (the application) filed in this matter by the applicants and as more fully described in the evidence received at the public hearing upon that application. The facility, known as Crystal River Unit 3 Nuclear Generating Plant, will be located at the applicants' site on the Gulf of Mexico, about seven and onehalf miles northwest of the town of Crystal River, Citrus County, Florida.
 - B. All references in paragraphs 3.C. and 3. of Provisional Construction Permit No. CPPR-51 to "applicant" are deleted and "applicants" is substituted.
 - C. Paragraph 2.D. has been added to read as follows:
 - D. This construction permit authorizes the Florida Power Corporation to have sole responsibility for the planning, licensing, design, construction, and pre-operational testing of Crystal River Unit 3 Nuclear Generating Plant.

This amendment is effective as of the date of its issuance.
