Arkansas Power & Light Company, Applicant in the above captioned proceeding, hereby files Supplement No. 8 to its Application for Licenses.


This Supplement No. 8 submits corrections of Supplement No. 7 and supplemental information in response to informal questions asked by the Staff of the Division of Reactor Licensing.
