Dear Ms. Whiting:

Enclosed is Amendment No. 17 to your NRC Materials License No. 21-24710-01 in accordance with your request.

Please note that your license format has been changed based on our Web-Based License System. In addition, based on licensing policy, the following license conditions were updated:

Condition 11 regarding the training record retention requirement for authorized users;

Condition 13 regarding the sealed source leak test requirement;

Condition 15 regarding the inventory requirement; and

Condition 17 regarding the security requirement for portable gauging devices.

We also deleted Condition 20 regarding the transportation requirement, which was listed in your previous license (Amendment Number 16). This does not relieve you from compliance with the transportation requirements. This condition was deleted because it was redundant to the regulatory requirements already specified in Title 10 Code of Federal Regulations, Part 71, "Packaging and Transportation of Radioactive Material."

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.


