In our letter to you of February 23, 1976, providing guidance on implementing the requirements of Appendix I to 10 CFR Part 50, we indicated that the staff was preparing additional guidance regarding the formulation of Tecanical Specifications to implement Section V.B.2 of Appendix I. In this regard we have attached guidance on the preparation of your proposed Technical Specifications.
