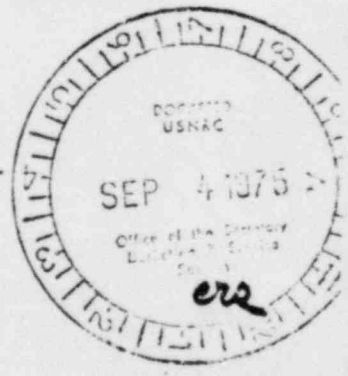
ERRATA TO INITIAL DECISION
