Gentlemen:

Your September 11, 1969 letter outlines your understanding of a tentative schedule for the remainder of the DRL review of the Midland Plant. As you know, discussions with your representatives on scheduling were presented on a speculative and optimistic basis, rather than a firm basis, as your letter implies. Mr. Boyd indicated our target date for requesting additional information regarding your application was the week of September 22. Mr. Boyd also stated that to complete our review in time for the February ACRS meeting we would need full and complete information from you by at least November 7. Should additional questions arise as a result of unsatisfactory or incomplete information being submitted, we could not predict what effect this might have on the review schedule.

My March 28, 1969 letter to you indicated that the Midland site is unacceptable for use with the reactor plant design initially proposed in your PSAR. Your Amendment No. 2, dated May 28, 1969, provides information related to design changes made as a result of this conclusion. Our request for additional information is based on our review of your initial application, as well as Amendment No. 2.

We are conducting our review of your application with full knowledge of your scheduling needs. Our ability to meet your requirements will depend in large measure on the adequacy and completeness of your application, as amended. We would be happy to discuss the progress on your application at any time.
