After Item 2, change the total to read "49" in lieu of 45, and delete the Total Amount of \$15,525.00 and substitute "\$16,071.84" in lieu thereof.

- B. Under ARTICLE II, DESCRIPTIONS/SPECIFICATIONS, add the following sentence:

"The Contractor, beginning May 1, 1980, shall deliver an additional four (4) subscriptions of "Inside NRC" in accordance with ARTICLE III, DELIVERY.

- C. Under ARTICLE III, DELIVERY, A. TIME OF DELIVERY, delete the first sentence and substitute the following in lieu thereof;

"Items 1, 1a, and 2 above shall be delivered on a biweekly basis."

Under B. PLACE OF DELIVERY, delete the reference to "forty (40) copies" and substitute "forty-four (44) copies" in lieu thereof.

- D. Under ARTICLE IX - Total Amount of Contract, the total amount of \$15,525.00 is deleted and \$16,071.84 is substituted in lieu thereof.

This modification results in an increase of \$546.84 from \$15,525.00 to \$16,071.84.
