This is in response to your letter dated May 27, 1980, in which you requested, pursuant to the Freedom of Information Act, the following records:

- "1. Summary of all medical radiation exposure (and/or absorbed radiation dose) data for occupationally exposed radiation workers that led the Nuclear Regulatory Commission to adopt "as low as reasonably achievable" as 0.1 the maximum permissable dose.
- "2. Any NRC or Advisory Committee summa, position papers that led the Nuclear Regulatory Commission to adopt "as low as reasonably achievable" as 0.1 the maximum permissable dose.
- "3. Any specific compilations of radiation exposures (and/or absorbed radiation doses) with nuclear pharmacy occupationally exposed workers either in the conduct of normal professional duties or in over exposure reports."
