On May 11, 1989 (Reference 1), you sent me a Differing Professional View regarding containment isolation valves (42" purge supply and exhaust valves) at Zion. Pursuant to NRC Manual Chapter 4125, and NRR Diffice Letter No. 300, I established a Panel to review your Differing Professional View and make recommendations to me regarding appropriate disposition of your concerns (Reference 2).

I have reviewed the Panel's report and have discussed these issues with you in a meeting in my office on September 8, 1989. Based on my review of the Panel's report and on our discussions, I have concluded that the following actions should be taken:

- The staff should issue its evaluation of the proposed Zion Technical Specifications. (Action--Projects, A/D for Region III & V Reactors)
- The staff should ensure that pressure and temperature effects during a 2. LOCA are considered in the review of new and advanced fuel designs. (Action--Reactor Systems Branch)
- The staff should revise the Standard Review Plan to clarify the relation-3. ship between DNBR and fuel failure. Such clarifications may be made during the normal SRP update process. (Action--Inspection and Licensing Program Branch)
