The NRC Region I SALP Board has reviewed and evaluated the performance of activities at the Yankee Nuclear Power Station for the period of April 1, 1988 through July 31, 1989. The results of this assessment are documented in the SALP Board Report provided as Enclosure 1. The assessment found the plant to have been operated and supported in a manner that reflected a strong management orientation toward safety. Although a few weaknesses were identified during this assessment period, it appears that corrective action programs are in place or planned to address deficiencies in these areas.
