Subject: ERROR IN THERAPEUTIC DOSE CALCULATION

On October 17, 1989, a 71-year-old female patient with uterine cancer underwent the first of three weekly brachytherapy treatments. The treatment involved the use of an iridium-192 sealed source.

The prescribed dose for each treatment was 600 rads, for a total of 1800 rads over the three-week period.

On October 18, the radiotherapy technologist told the prescribing physicist that the treatment time for the 600 rads on October 17 seemed longer than normal. The physicist recalculated the dose and determined that an error in the treatment time had been made. The patient had received 1200 rads rather than the prescribed 600 rads.

A revised treatment plan has now been formulated. The patient will receive only one more treatment of 600 rads. Thus, the final administered dose will still be 1800 rads.

The patient's attending physician was notified of the error. The licensee does not expect any significant clinical effect due to the error.

Region III (Chicago) will review the circumstances of the event during a future special inspection.
