Dear Mr. Collopy:

This letter is in regard to your letter, with enclosures, dated September 29, and October 2, 1989 whereby you submitted certain revisions to your currently approved 10 CFR Part 70 Fundamental Nuclear Material Control (FNMC) Plan. The enclosures to your September 29, 1989 letter contained changes provided for under the provisions of 10 CFR 70.32(c) while the enclosures to the October 2, 1989 letter contained proposed changes pursuant to 10 CFR 70.34.

We have determined that the revisions made under the provisions of 10 CFR 70.32(c) are acceptable in that they are consistent with regulatory requirements and meet the intent of regulatory guidelines and standards. We have further determined that the proposed changes made pursuant to 10 CFR 70.34 are also acceptable in that the changes will not decrease the effectiveness of your safeguards program, nor will they adversely affect the common defense and security nor the public health and safety, and are otherwise in the public interest. Accordingly, License Condition 2.1 to Safeguards Amendment SG-1 to your License No. SNM-368 is hereby revised, effective upon receipt of this letter, to read as follows:

2.1 The licensee shall follow Chapters 1.0 through 8.0 of its Fundamental Nuclear Material Control (FNMC) Plan, dated January 6, 1988, designated as Revision 8; pages 4-25, 7-5 and 7-5a dated August 15, 1988 (Revision 9); pages 7-8 and 7-8A dated January 16, 1989 (Revision 10); pages 4-5, 4-21 and 4-21a dated January 27, 1989 (Revision 11); page 5-6 dated February 15, 1989 (Revision 13); pages 2-1c, 2-2, 2-4 and 7-7 dated February 20, 1989 (Revision 12) as well as the commitments contained in UNC's February 22, 1989 letter to D. J. Kasun, Acting Chief, Domestic Safeguards and Regional Oversight Branch, NMSS, USNRC; the pages dated April 1, 1989 (Revision 14); pages 3-6, 5-2, 5-4 and 7-5 dated June 2, 1989 (Revision 16); pages 1-3, 1-5 and 2-1 dated October 9, 1989 (Revision 17); pages 1-6, 1-7, 2-3, 2-5, 4-9, 4-10, 4-11, 4-15, 4-17, 4-19 and 4-20 dated October 1, 1989 (Revision 18); and as may be revised in accordance with, and pursuant to, the provisions of either 10 CFR 70.32(c) or 70.34.

We have determined that the enclosures to your letters sated September 29, and October 2, 1989 contain information of the type specified in 10 CFR 2.790(d). Accordingly, pursuant to Section 2.790(d)(1), such information is deemed to be commercial or financial within the meaning of 10 CFR 9.17(a)(4) and shall be with all from public disclosure unless subject to the provision of 10 CFR 9.23.
